

QUALITYNET'SERVICENOW' Q&A TOOL UPDATE

On October 21, 2019, the new *QualityNet* Question and Answer (Q&A) tool went live with a new look and simplified navigation aimed at making information about *QualityNet* programs easier to find. The new Q&A tool called ServiceNow replaced the former RightNow Q&A tool.

The Centers for Medicare & Medicaid Services (CMS) is committed to making the new ServiceNow tool even better. The team is working on developing similar "My Stuff" functionality in the new Q&A tool. In the near future, the *QualityNet* ServiceNow Q&A tool will include new functionality that allows users to lookup in-process and historical information.

UPDATED INTERIM INFECTION PREVENTION AND CONTROL RECOMMENDATIONS FOR MEASLES IN HEALTHCARE SETTINGS

CDC's updated [Interim Infection Prevention and Control Recommendations for Measles in Healthcare Settings](#) can help clinicians protect against the spread of measles. Measles is most commonly spread from person to person either at home or in public settings, but it can also

spread in healthcare settings. While the most important way to prevent the spread of measles is community vaccination, core measles prevention in healthcare settings requires a multi-faceted approach including:

- Ensuring healthcare personnel (HCP) have presumptive evidence of immunity to measles
- Rapidly identifying and isolating patients with known or suspected measles
- Adhering to Standard and Airborne Precautions for patients with known or suspected measles
- Routinely promoting and facilitating respiratory hygiene and cough etiquette
- Appropriately managing exposed and ill HCP

CDC's interim guidance should be implemented as part of a comprehensive infection prevention program to prevent the spread of germs among patients, healthcare providers, and visitors.

CMS Updates

FINAL RULE EXPLAINS CHANGES TO THE END-STAGE RENAL DISEASE QUALITY INCENTIVE PROGRAM (ESRD QIP)

On October 31, 2019, the Centers for Medicare & Medicaid Services (CMS) issued a final rule that updates payment policies and rates under the End-Stage Renal Disease (ESRD) Prospective Payment System (PPS) for renal dialysis services furnished to beneficiaries on or after January 1, 2020. This rule also updates the acute kidney injury (AKI) dialysis payment rate for renal dialysis services furnished by ESRD facilities to individuals with AKI and finalizes changes to the ESRD Quality Incentive Program (QIP). The final rule is displayed in the October 31, 2019 Federal Register. [Download the final rule.](#)

TIME-LIMITED RELIEF FOR PART B PREMIUM PENALTIES

Under this time-limited policy-known as equitable relief-people who are eligible for Medicare and have Marketplace coverage can apply to enroll in Medicare Part B without penalty. Those who have already transitioned to Medicare can request that any Part B late enrollment penalties they may have received be reduced or eliminated. Eligibility for this ends on June 30, 2020. NHSN TO BEGIN COLLECTING INDIVIDUAL DIALYSIS EVENT DATES IN 2020

The National Healthcare Safety Network (NHSN) will begin collecting individual dialysis event dates in 2020. Currently, related events are reported on one form, with one event date (for example, positive blood culture and a related IV antimicrobial start). NHSN is moving toward collecting an individual event date for each event type, even if the events are related. Individual event date fields will be optional in 2020 and required by 2021. TRANSITION PERIOD FOR NEW MEDICARE CARD ENDS SOON

Starting January 1, 2020, you must use the Medicare Beneficiary Identifier (MBI). Claims submitted with the Health Insurance Claim Number (HICN) will be rejected, with [a few exceptions](#) and reject all eligibility transactions. Protect your patients' identities by using MBIs now for all Medicare transactions. Ask your patient for his or her card.
